WALL MOUNT INSTALLATION

PACKAGE CONTENTS

Wall Mount VNX-AC-WBBK-0

Wall Bracket

When unpacking, check to see if there is any visible damage to the appearance of the mount. Remove any protective materials from the bracket after every item is properly checked.


INSTALLATION

Select a mounting location that is clear from any obstacles, such as steel beams, pipes, etc., that would interfere with mounting. Route any necessary cabling to the installation site.

Install the Base from the Fixture Kit

The centerline refers to the home position of the camera lens, and before you begin your installation, you'll need to determine where that home position will be. Once installed, the "C" (for centerline) on the Base will align with the Vicon logo on the Solo Fixture and the lens home position (default position out-of-the-box). So, before you mount the Base to its surface, make sure the "C" on the Base reflects your home position.


For wall surface mount applications, the centerline will be facing down.




Mount the Base to the Surface

1. Drill a cable access hole in the surface where the camera will be mounted and expose the Ethernet cable and alarm wiring.

NOTE: Provide sufficient cable length to run through the Wall Mount.




2. Once you've determined your centerline, use the Base to mark holes for the four mounting screws.




Reminder: The "C" on the Base indicates the centerline, which is the lens home position. For wall mount applications, the C should be facing the floor.


3. Set the Base aside; drill holes and install plastic anchors in those holes (06.35 mm).



4. Reposition the Base and attach it to the surface using supplied screws.





- 5. Run Ethernet and Alarm I/O cable through the Base.
- 6. Run Ethernet and Alarm I/O cable through the Wall Mount.
- 7. Twist install the Wall Mount to the Base.



Connect the Cables

1. Connect Ethernet and Alarm I/O cables as required to the pigtail of the Network Hub (use RJ-45 connector kit as required for outdoor installations.







2. Push cables back into the Wall Mount.

Assemble the Components


1. Align the single dot indicator on the Network Hub with the dot on the Wall Mount and firmly snap the Network Hub into place.



2. Align the two lock screws on the Solo Fixture with the double dot indicators on the installed Network Hub.




3. Twist the Solo Fixture to the right to lock it into place. The Vicon logo on the Solo Fixture is now aligned with the Base's centerline ("C").




Install the Camera Sensor

1. If using edge recording for On-Prem or Anavio solutions, install the Vicon Edge Recording Card (VNX-EL-SD1T-0).




NOTE: Only the Vicon Edge Recording Card VNX-EL-SD1T-0 is accepted.

2. Align the double dot indicators on the Camera Sensor with the two lock screws on the Solo Fixture, then twist it to the right to lock it into place.



- 3. Upon successful power-up, the LED lightbars on the Camera Sensor will flash green for 5 seconds.
- 4. Turn the security screw approximately 2 turns maximum until it contacts the Base and Camera Sensor. This prevents the camera from being removed. No torque is required. For added security, use the T8 Security Torx wrench to tighten the three lock screws (2x on Fixture, 1x on Wall Mount).

NOTE: Do not overtighten; overtightening can strip the threads.




Installing the Wall Mount with the Conduit Box

- 1. Identify the Centerline and Security Lock Screw on the Conduit Box cover.
- 2. Open the hinged cover of the Conduit Box.



3. Remove the conduit plug from the cable access hole that will be used for conduit entry for this installation (there are 4x conduit plugs).




4. Using the Conduit Box as a template, mark the mounting holes.




NOTE: The C indicates the centerline for the camera installation.

- 5. Drill the mounting holes.
- 6. Mount the Conduit Box using the TP4 screws with inserts provided or other customer-supplied hardware appropriate for the mounting surface.



7. Pull cables into Conduit Box.


NOTE: Provide sufficient cable length to run through the wall bracket.




8. Close the cover.




- 9. Pull cables through the Wall Mount.
- 10. Twist install the Wall Mount to the Conduit Box cover.




- 11. Connect Ethernet and Alarm I/O cables as required to the pigtail of the Network Hub.
- 12. Push cables back into the Wall Mount.
- 13. Align the single dot indicator on the Network Hub with the dot on the Wall Mount and snap the Network Hub into place.




14. Align the two lock screws on the Solo Fixture with the double dot indicators on the installed Network Hub.



15. Twist the Solo Fixture to the right to lock it into place. The Vicon logo on the Solo Fixture is now aligned with the Base's centerline ("C").




16. If using edge recording for On-Prem or Anavio solutions, install the Vicon Edge Recording Card (VNX-EL-SD1T-0).



NOTE: Only the Vicon Edge Recording Card VNX-EL-SD1T-0 is accepted.

17. Align the double dot indicators on the Camera Sensor with the two lock screws on the Solo Fixture, then twist it to the right to lock it into place.



- 18. Upon successful power-up, the LED lightbars on the Camera Sensor will flash green for 5 seconds.
- 19. Turn the security screw approximately 2 turns maximum until it contacts the Base and Camera Sensor. This prevents the camera from being removed. No torque is required. For added security, use the T8 Security Torx wrench to tighten the three lock screws (2x on Fixture, 1x on Wall Mount).
